PURCHASE AND INSTALLATION OF NEW MANUFACTURED HOME LOCATED AT: 560 30th Avenue Space 55, Santa Cruz, CA 95062

Bidders are hereby informed that the project documents are modified as follows:

- 1. Parking requirements for this project include space for two vehicles. Covered parking of one vehicle is desired, but is not mandatory. Per County Code Section 13.10.552 In order to meet the parking requirements for a mobile home located within a mobile home park, one off-street parking space may be a compact space, three cars may park in tandem, and one space may overhang a landscaped area.
- 2. Electrical service must be upgraded to 50 amps and no more. The "utility room" electrical specification will be modified, as needed in proposals, to conform with maximum allowed amps.
- 3. Proposal will include additional "ALTERNATE" price breakdown for relocating electrical, natural gas, sewer and similar coach connections, if needed to comply with parking requirements and coach size requirements.
- 4. Proposal will include additional price breakdown for "Site Work" related to the "Asphalt" and "Landscape related" specification items. These items are to be grouped and itemized by A) work needed at space #55, and B) work needed at neighboring lot parking space. The following "OFFICIAL PROPOSAL FORM REVISED" will be included in all proposals (and will supersede the original proposal form).
