BACKGROUND SUMMARY:

The Department of Housing and Community Development (HCD) has developed a final negotiated contract for the operation of the Buena Vista Migrant Center in the amount of \$429,445 for fiscal year 2019-2020 and \$432,905 for fiscal year 2020-2021, not to exceed \$862,350 for the biennial contract. HCD has requested that the resolution exceed the amount of the negotiated contract by 10% as an allowance for future contract amendments. As a result, this resolution seeks authorization to execute a contract, and any amendments, in an amount not to exceed \$948,585. Although staff has been working with HCD for months attempting to finalize a contract, we have only recently been informed of the final negotiated contract amount. However, given that our previous contract expired on 6/30/19, HCD has requested this approval as quickly as possible so that a new agreement may be signed.

The biennial contract for FY2019-2021 includes an increase in funding of \$100,748, or 13%, compared to the biennial contract for FY2017-2019. The contract covers anticipated operating and maintenance expenses, salary and benefits for onsite Housing Authority staff, and administrative support funding which serves as a management fee to cover indirect personnel costs and overhead.

BACKGROUND SUMMARY:

Over the course of the past year, the Housing Authority has accomplished several major achievements through the extraordinary work of staff. In July 2018, the Agency moved to our new mid-County location in Capitola. Once we settled into our new location, work began immediately on preparing for and implementing a Section 8 waiting list opening after a nearly ten-year closure. Within days of successfully completing the waiting list opening, the Agency entered into a contract with a new software vendor and began a lengthy and complex conversion to a new software platform to run our day to day operations. For each of these major Agency achievements, especially the recent software conversion, staff at all levels of the organization worked long and hard to ensure these efforts were successful.

Management would like to thank and reward all staff for their extremely hard work and positivity over the course of this uncharacteristically challenging year by granting <u>one</u> additional paid holiday, to be used in 2019.

Management has been advised by legal counsel that: 1- A public agency employer's provision of benefits to its employees, including bonuses, serves a public rather than private purpose by helping to recruit and retain qualified and competent employees; and 2- a bonus holiday approved by the Board would therefore not constitute a gift of public funds, which would be illegal under California law.

RESOLUTION AUTHORIZING THE GRANTING OF ONE ADDITIONAL HOLIDAY TO ALL HOUSING AUTHORITY EMPLOYEES FOR 2019.

WHEREAS, the Housing Authority of the County of Santa Cruz recently underwent an office move, a waiting list opening, and a lengthy and complex conversion to a new software platform, all in one single year; and

WHEREAS, staff at all levels of the organization worked tirelessly and successfully to ensure these endeavors would be accomplished as seamlessly as possible and provide the greatest possible benefit to the Authority's applicants, participants, and landlords; and

WHEREAS, California law permits public agencies to provide benefits to employees, including bonuses, if said bonuses serve a public purpose such as helping retain qualified and competent employees and therefore do not constitute a gift of public funds.

NOW, THEREFORE, BE IT RESOLVED THAT

1. The Housing Authority of the County of Santa Cruz hereby grants, on a one-time basis, one eight (8) hour holiday (prorated for part-time employees) to all employees who were employed on July 1, 2019. This holiday shall be taken on December 26th, 2019, during the agency closure when staff would have ordinarily been required to use a vacation day, except for employees who terminate their employment prior to that date, who may take the holiday as a floating holiday as described in the Personnel Policies.
